## **Instructions for Completing Membership Application**

- Complete Name/Address section, including Social Security or Federal Identification Number
- Complete “Qualifications for Voting Membership” section. (Eligibility criteria explained below.)
- Sign the membership declarations box on back of application.
- Include your \$10 membership fee. This is a one-time fee.
- Return to Producers Cooperative in person or by mail.

## **Qualifications for Membership**

***Any person, firm, partnership, corporation or association, including landlords and tenants, to qualify for membership, must be a producer of agricultural products intended for resale, and be a purchaser of supplies and/or services offered by this Association.***

The following criteria will be used to help determine qualification of individuals and/or groups applying for membership. Regardless of the size of an operation, applicants must meet the criteria listed below:

- 1)** Applicant should own or lease land that could generally be recognized as being used for the production of agricultural products.
- 2)** Applicant should own, produce and market animals or crops, which are grown in the production of food and fiber, or are generally considered to be associated with the agricultural industry. (Specialty groups such as aquaculture, horticulture, or other animals or crops will be given consideration if Point #3 below is satisfied.)
- 3)** Applicant should receive regular income from the operation, as a result of the marketing of these commodities.

**PLEASE NOTE:** Once applications are approved, the membership is not activated until a purchase has been made.
